The Alburnett City Council met in regular session **Thursday April 17, 2014** at Alburnett City Hall. Mayor Boesenberg called the meeting to order at 7:00 PM with councilmen Titler, Gudenkauf, Trumm, Schantz present. Also present were Deputy Egu, ChrisAnderson, Bill Sloan, Guy Trimble and Matt Annis.

Motion to approve the agenda was moved by Schantz, second by Titler. Motion carried.

Sheriff's Report – Deputy Egu reported there were 26 calls totaling 69.0 hours of service last month. Council reminded the Deputy that scooters were coming out with the warmer weather and to watch for illegal riders.

Fire Department Report – Craig Titler reported there were eight calls of service last month. Five medical calls in the township, one fire in the township, one grass fire – mutual aid and one PR – Annual Fire Grill. Craig has been working on truck #135 and it is just about ready to be put back into service. The year end report tallying the meetings and calls that each volunteer attended was given to the council.

Bill Sloan presented the idea of leasing the area around the lagoons to graze sheep. Bill will maintain the fence, carry liability insurance and remove the sheep if or when the grass gets too short. Motion to sign a one year lease agreement with Bill Sloan to graze 15-20 sheep at the city lagoon site was moved by Schantz, second by Gudenkauf. Motion carried.

Kirk Sauer, Linn Co-Op Elevator presented a site plan and cost for a 6" water line and fire hydrant at 310 Railside Drive. Council will send the information to the city engineer for review.

Kevin Shoop, contract affidavit operator, spoke about DNR approval to by pass on Sunday April 6, due to the 4" rain. Sample were taken at the lagoons and when results come back we can begin lowering the level of the lagoons. Chad from DNR suggested we run only one well for a month to determine the proper amount of chlorine needed for that well. When that is determined we will handle the other two wells in a similar manner.

Chris Anderson inquired about a meeting with the fire department, township trustees and council. There will be a workshop on May 22 at 7:00 PM at Alburnett City Hall.

Matt Annis spoke about the residential lot next to his property at 141 3rd Street. Matt will be notified when the planning and zoning meeting is scheduled.

Motion to approve the consent agenda with the addition of 5 invoices; Radio Communications - \$8.12, Fire Chief Association dues - \$25.00, Med Compass - \$416.00, Master's Auto - \$4,307.00

and Kirkwood Community College - \$30.00, was moved by Schantz, second by Trumm. Motion carried.
