### **Ordinance #2202-2 PROPERTY MAINTENACE REGULATIONS**

**SECTION 1: PURPOSE.** The purpose of this chapter is to establish rules and regulations for property maintenance in the City of Alburnett, Iowa.

**SECTION 2:** INTERNATIONAL PROPERTY MAINTEANCE CODE ADPOTED. The City of Alburnett herby adopts International Property Maintenance Codes, edition currently adopted by the Linn County Iowa Code of Ordinances.

# ORDINANCE #2202-3 BUILDING DEPARTMENT RENTAL INSPECTIONS

**SECTION 1: PURPOSE:** The purpose of this chapter is to establish rules and regulations for rental property in the City of Alburnett, Iowa established by the Linn County Property Maintenance and Housing Codes.

**SECTION 2:** Adoption of the Linn County building Department Rental Inspections for the City of Alburnett, Iowa.
